4. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on above mentioned time. Bids received after this deadline will be rejected.

- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend on above mentioned time at the office Susta Rural Municipality Office, Kudiya, Nawalparasi (Bardaghat Susta west).
- Submission of signed Letter Of Bid, along with the copy of company/ firm registration certificate, Business Registration certificate(License) and renew certificate, VAT registration certificate, tax clearance certificate up to FY 2077/078 and time extension in case of previous FY clearance is compulsory.
- 7. If last date of purchasing and/or submission falls on a government holiday, then next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same prescribed for the original last date of bid submission. The bid validity and bid security shall be counted after date of bid opening.

8. Susta Rural Municipality reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.

9. Any provisions which are not mentioned in this notice will be consistent with PPA 2063, PPR 2064 and other prevailing Nepalese Laws.
